### **Michael Wolff & Impure Thoughts Requirements**

*In order for your Michael Wolff show to be as successful as possible, please provide the following items:*

- 5 large clean terry cloth towels, no bar towels
- A hot meal (fish, chicken or turkey, no red meat please and one vegetarian option) for each musician plus one for road manager, or buy out 15 dollars per head (6)
- Assortment of fresh fruit, apples, oranges, bananas, berries, etc
- Assortment of teas, herbal and regular
- One pot of hot water
- One pot of decaf coffee
- 14 small bottles of still spring water, 4 bottles of carbonated (Perrier or equivalent)

*All drinks should be well iced throughout the evening.*

*Please provide the above at sound check unless otherwise instructed from the tour manager.*

### **SUPPORT / OPENERS**

Management or the booking agent must approve all support requests and suggestions unless otherwise contracted.

### **COMPLIMENTARY TICKETS**

Purchaser to provide 4 complimentary tickets for *each* band member and 5 complimentary tickets for the office.

In the event the house is turned we will be allowed a new comp list.

### **MERCHANDISING**

Michael Wolff will be selling merchandise. We request that the Venue offer one competent person to vend merchandise for the duration of the performance. Compensation for the vendor will be negotiated by the tour manager or negotiated in the hall commission.

### **RECORDING**

- No audio or video recording, nor any reproduction or transmission of the performance will take place without the written consent of the management.

### **INTRODUCTIONS**

All introductions are to be approved and reviewed with band representative or Michael Wolff prior to the start of the show.

### **ACCOMODATIONS**

In the instance where the Purchaser agrees to book and pay for hotel rooms, they must meet the following requirements:

- Non-smoking
- King, single rooms
- Four Star quality or higher

Purchaser must obtain approval from Management on hotel booking before confirmation and supply the hotel name, address, phone and fax number along with any contact names.

Once confirmed, confirmation numbers are to be e-mailed with the rooming list to LVanHart Artist Productions (lhartmann@sprintmail.com).

### **GROUND TRANSPORTATION**

The Purchaser must provide ground transportation to and from the airport, hotel and venue.

#### Acceptable Vehicles

Vehicle must have proper seating, including seat belt, for each musician and crew member. Vehicle must be clean and in safe working condition with ample room for luggage and instruments. A 15- passenger van will usually accommodate 6 people, plus luggage and equipment. Please check with Management to confirm.

### **WORK PERMITS AND VISAS**

Purchaser must provide work permits and/or visas for all musicians and working personnel when traveling outside North America. Purchaser is responsible for any fees/charges for work permits or any airport entrance/exit taxes

### **EXCESS BAGGAGE CHARGES:**

Purchaser shall reimburse ARTIST for any overweight costs incurred from the airlines for musical instruments. ARTIST will provide airline receipts not to exceed \$350.

### **CANCELLATION**

In the event Artist secures an involvement with a major motion picture, stage play, video production, or a television show, Artist reserves the right to cancel the engagement at Artist's sole discretion with a written notice to the purchaser 30 days prior to the date of the engagement.

### **FORCE MAJEURE**

Artist shall neither be held responsible nor shall a claim be made against Artist for cancellations beyond Artist and producer's control or for concerts affected in ways including, but not limited to public calamity or riots, epidemic, fire, serious illness or injury.
